

## **FSHL TEAM REGISTRATION REQUIREMENTS**

**TEAM FEES - \$ 12,900.00 For Returning Teams  
\$ 13,050.00 For New Teams (Includes Team Banner)**

### **PAYMENT DUE DATES**

**\$ 1,000.00 Deposit Due June- 2011**

**\$ 5,950.00 Due September 30, 2011**

**\$ 5,950.00 Due October 30, 2011\***

**\*New Teams may submit the \$150.00 for the banner with the  
October 30, 2011 installment.**

**NOTE: ALL THE TEAM CHECKS MUST BE IN THE FORM OF A BANK CHECK  
MADE PAYABLE TO: FSHL**

### **FSHL PLAYER ROSTER FORM**

This form must be completed and returned with the USA Hockey membership receipts to the league by **October 1, 2011**.

**USA HOCKEY MEMBERSHIP DUES** – Online registration is now available for all team members and coaches. Direct your players/coaches to go online to [www.usahockey.com](http://www.usahockey.com) to register using a credit card to pay for their fees. The fee is \$38.00. (\$30.00 goes to USA Hockey and \$8.00 goes to SAHOF)

Print out the receipt with the waiver/confirmation number and have each player/coach give the confirmation paper to the Manager.

The team manager will then send in one mailing all the membership confirmation receipts from the team to the registrars.

Players or coaches who have not properly registered with USA Hockey will be ineligible to practice or play in games with the team.

## **LEGAL FORMS – DUE BY OCTOBER 1, 2011 TO THE REGISTRARS**

The following forms must be completed by the players, coaches and parents, and returned to the team managers. The team managers will then forward all packets in one mailing to the Registrars. All forms can be found on the website [fshl.cc](http://fshl.cc)

## **TEAM MANAGER'S RESPONSIBILITIES**

Team Managers will be required to maintain a binder with the following:

1. COPY OF FSHL PLAYER ROSTER FORM
2. COPY OF PLAYERS BIRTH CERTIFICATES
3. COPY OF CURRENT PICTURE SCHOOL ID OR CURRENT CLASS SCHEDULE
4. COPY OF COACHES USA HOCKEY EDUCATION CERTIFICATION CARD
5. STUDENT REPORT CARDS
6. USA CONSENT TO TREAT FORM-----FOR ALL PLAYERS, COACHES AND  
MANAGER

**NOTE: Team Managers will be required to bring the above documents in a binder to all FSHL practices and games, and to present them, upon request, to League Officials for verification.**

## **General Information**

Teams may add players to their roster through December 31, 2011 but cannot go on the ice for practices or games until that player is properly registered with USA Hockey and the FSHL Registrars.

According to USA Hockey Rules, a roster may carry 30 players; however, only 20 players may be on the bench at one time - 18 skaters and 2 goalies. Once a player is on a roster, that player takes up a roster spot even if that player becomes ineligible during the season.

## **SCORE SHEETS**

ALL COACHS AND REFEREE'S SIGNATURES MUST BE ON EACH SCORE SHEET OR THE USA HOCKEY REPRESENTATIVE WILL NOT SIGN OFF ON IT.

ONLY PLAYERS THAT ARE PRESENT AT A GAME WILL APPEAR ON THE SCORE SHEET. CROSS OFF THEIR NAME IF THEY ARE NOT PRESENT.

IF A PLAYER IS SERVING A SUSPENSION HE/SHE MUST SIGN THE SCORE SHEET BUT WILL NOT GET CREDIT FOR A GAME PLAYED.
